IMPORTANT: For all options involving golfing benefits, 25% of the amount collected will be payable to the ASM Golf (S) Pte Ltd, the Asian Seniors Tour's event management company. The net proceeds (75%) will go towards supporting ISCOS ReGen Fund (IRF), a registered charity that provides holistic and empathetic support to reformed offenders, their children and families to prevent intergenerational offending.

For donations where donors do not wish to take up any golfing benefits, the full donation will go towards IRF.

¹ Each Pro-Am flight caters to 3 amateur golfers, to be accompanied by a professional golfer. If desired, the donor may field 4 amateur golfers and not have a pro play in their flight.

² If the donor wishes to give S\$20,000 but only requires one Pro-Am flight, then the amount payable to ASM Golf (S) Pte Ltd would be S\$2,500 with the remaining S\$17,500 going to IRF.
